The issuance of the permit does not imply nor insure the City Of Oronogo Utilities are located on your lot/property or project nor does it imply the City will incur the cost to bring the City Of Oronogo Utilities to your Lot/Property or project for either residential or commercial projects. (Utilities definition includes sewer lateral/sewer main/water service connection)

Please call 24 hours in advance to schedule an inspection; failed inspections require correction and a \$50 re-inspection fee before further inspections This permit is valid for 3 months from date of issue.
